A new study published today by the European Patent Office (EPO) finds that small and medium enterprises (SMEs) rely on European patents to protect their high-potential inventions and that two thirds of these inventions are commercially exploited. The study, entitled "Market success for inventions – Patent commercialisation scoreboard: European SMEs", finds that SMEs depend heavily on partnerships with domestic or foreign partners. The report shows that half of all commercialised inventions protected either by a European patent application or a granted European patent are exploited in collaboration with an external partner via a licencing agreement (62% of the respondents), co-operation (49%) or spinoff (32%). Moreover, the partner is usually from ano... Read more

The 2019 edition of WIPO's World Intellectual Property Report analyzed millions of patent and scientific publication records across several decades to conclude that innovative activity has grown increasingly collaborative and transnational, while originating in a few large clusters located in a small number of countries. Some 30 metropolitan hotspots alone accounted for 69 percent of patents and 48 percent of scientific activity during the 2015-2017 period. They are mostly located in five countries – China, Germany, Japan, the Republic of Korea and the United States of America (U.S.). The said programme will initially commence between Japan Patent Office (JPO) and Indian Patent Office, under the Controller General of Patents, Designs and Trade Marks (CGPDTM), on pilot basis for a period of three years only, an official statement said. Under this pilot programme, the Indian Patent Office may receive patent applications in certain specified technical fields only, namely, electrical, electronics, computer science, information techno.... To help the United States Patent and Trademark Office (USPTO) maintain the integrity of the trademark filing process, we recommend that attorneys proactively monitor our database for trademark filings that use their names, signatures, and contact information without their knowledge or consent.

We're actively monitoring and addressing this issue, which appears to involve a relatively small number of filings. Still, we recommend attorneys regularly check the filing database for use of their information.

**Monitor your information in filings :-** To search for records in which you are designated as the attorney-of-record, use the Trademark Electronic Search System (TESS): ... Read more

Earlier in 2019, IP Australia sought public comment on the exposure draft of regulations to amend the Trade Marks Regulations 1995 to allow division of International Registrations Designating Australia ("Division of IRDAs"). Noting that there is currently no international requirement to make this change now, IP Australia is not intending to seek the making of the amending regulations in the near future. We consider that it would be better to consider the issue of division of IRDAs as part of a broader holistic consideration of trade mark timeframes which we propose to conduct in the future. We will continue to keep stakeholders informed on any activities concerning the division... Read more

The Turkish Industrial Property Code no. 6769 (IP Code) grants protection through registration for the appearance of a product or a part thereof. According to the IP Code, the protection is applied to the appearance of the whole or a part of a product or its ornamentation resulting from features such as lines, shape, form, color, material or surface texture that fulfill the novelty and individual character criteria. In other words, designs which lack novelty and individual character do not fulfill protection requirements. The requirement for novelty acknowledges that no identical design should have been made available to the public anywhere in the world before the date of reference. The assessment of the individual character however, di... Read more

The European Patent Office (EPO) and the National Institute of Industrial Property of Brazil (INPI) have signed a Memorandum of Understanding on a Reinforced Technical and Strategic Partnership to enhance co-operation between Europe and Brazil in the area of patents. The MoU was signed by EPO President António Campinos and INPI President Cláudio Vilar Furtado today in Rio de Janeiro.

The agreement between the EPO and Latin America's biggest patent office is aimed at strengthening the patent systems in Brazil and Europe in order to support innovation and economic development, and foster bilateral trade and investment between the two regions.

"Brazil is a key partner for the EPO and an important market for European companies," said EPO President Campinos. "This agreement is a milestone in our co-operation and is testament to the economic importance of close ties between our regions. Our co-operation aims to ensure efficient patent examination and the granting of high-quality patents. It should thus benefit both local innovators and international patent applicants, who can increasingly expect to find similar conditions for protecting their inventions around the world."

INPI President, Cláudio Vilar Furtado, highlighted the importance of the agreement to stimulate investment in innovation and industrial property, focusing on the generation of new patents, especially in partnership. "In this agreement betwee... Read more
