The INPI platform now includes additional features such as an improved Goods&Services search and similarity report document for TM e-filing, or multiple files upload and DS Class integration into DS e-filing, which will help modernise the IP-related operations in Portugal. Newly founded companies in possession of patents have a greater chance of obtaining these state-sponsored contributions. An additional benefit of owning a patent is that it can be used as collateral for a loan and allows for diversified financing. In order to expedite the patent acquisition process for startups, TIPO will begin implementing the "Positive Patent Examination Pilot Program for Startup Companies" on January 1 of next year. This will give priority to invention patent applications filed by newly established companies. Similar group codes are the codes assigned to goods and services that are presumed to be similar to each other in trademark examination. The IPO will start accepting Form 5-1 under Chapter 5 of the PPH Guidelines from 7th December 2020. The number of requests will be limited to 100. Following points are to be noted while submitting a request to IPO under the said PPH program:

**1**. The number of the requests for the PPH in IPO will be limited to 100 cases per year on first come first serve basis.. Read more

#### 5. Changes in Individual Designation Fees: Russian Federation

- **1.** 138 Swiss francs for the first design and 29 Swiss francs for each additional design, when designating the Russian Federation in an international application;
- **2.** 219 Swiss francs for the first renewal, 538 Swiss francs for the second renewal, 800 Swiss francs for the third renewal and 1,392 Swiss francs for the fourth renewal of an international registration in which the Russian Federation is designated.

#### 10. China Releases Draft Implementation Rules of the Patent Law

On November 27, 2020, the China National Intellectual Property Administration released the draft implementation rules for the amended Patent Law (专利法实施细则修改建议(征求意见稿)). The draft rules cover changes required to implement the amended patent law, including patent term extension and adjustment, partial design patents, open licensing system and other areas. The draft rules also add the right to restore priority.

Designs - Article 27 is amended to include a new paragraph regarding newly allowed partial designs: If you apply for a partial design patent, you should submit a view of the overall product, and use a combination of dotted and solid lines or other means to indicate the content that needs to be protected. As we reported in November 2019, the USPTO has been making significant revisions to its rules to combat an influx of fraudulent trademark filings. Some of the biggest rule changes last year were to specimen requirements. The USPTO required that screenshots of websites needed to show the full URL and date, and that product packaging needed to be accompanied by an image or description of the product. In other words, hangtags by themselves or empty boxes were no longer acceptable. In the wake of these new rules, practitioners and pro se trademark applicants also saw an increase in refusals on the basis that a specimen was a "mockup" or something that "only exists in cyberspace." Until recently, a "mockup" refusal could be issued where... Read more

For instance, accelerated examinations can be requested at other IP offices when at least one claim is determined patentable in the ISR provided by the JPO. Currently, we implement the PCT-PPH with 37 IP offices based on our ISRs. For conducting international search, we accept PCT applications filed in English, which means you can do without Japanese translation. Let the JPO facilitate the prosecution of your patent applications worldwide... Read more
