Fees for European patent applications are changing from 1 April 2024. These include reductions for small companies and even the abolition of some fees. Internal renewal fees are rising by less than the rate of inflation resulting in a decrease since 2016 in absolute terms. Following a comprehensive review of the EPO's fee system by the Administrative Council, a number of important fee changes come into force on 1 April 2024. This package of fee measures introduces dedicated fee reductions for micro-entities, simplifies the fee system, creates incentives for further digitalisation, and secures the Organisation's financial sustainability through moderate increases of procedural and internal renewal fees. TRIPOLI – The Libyan Ministry of Economy issued Resolution No. 26 of 2024 presenting new executive regulations for Chapter Ten regarding trademarks of Law No. 23 of 2010 on Trademarks. The executive regulations define the true nature of the trademark, the trademarks that are not registrable, registration procedures, the expiry of marks property and their mortgage, registration renewal and cancellation, and the disputes concerning trademarks registration and property and how to solve these disputes. One of the salient changes brought by the executive regulations involves the increase in official fees payable for all services provided by the Libyan Trademark Office.... Read more

The pledgee was the Moscow Small Business Credit Assistance Fund. Eurasian industrial design patent does not only protect one's exclusive right to an industrial design in seven countries simultaneously on the basis of one single patent. A Eurasian patent is also an intangible asset of the patent owner who is entitled to transfer... Read more

#### 09. Adopting the Madrid Goods and Services list

AUSTRALIA - THE NEW

IP Australia will replace the current Trade Marks Goods and Services list (the AU picklist) with the Madrid Goods and Services (MGS) list in 2024.Portrait of Enthusiastic Hispanic Young Woman Working on Computer in a Modern Bright Office The MGS list is a database of terms used to classify goods and services for trade mark applications in the Madrid System. It's used by the World Intellectual Property Organization (WIPO) and many international trade mark offices. It contains a wider range of terms than the AU picklist. Adopting the MGS list will align Australian classification standards with international best practice. This change will make it easier for Australian exporters to protect their trade marks in other countries This change is expected to take place in March 2024. At that time, we'll also be introducing a semantic search function. This update will help customers find terms on the MGS list that have a similar meaning to the term they're looking... Read more

The Geneva Act (1999) of the Hague Agreement Concerning the International Registration of Industrial Designs is set to take effect in Greece on February 13, 2024, followed by Italy on March 14, 2024. The ratifications by Greece and Italy bring the total number of Contracting Parties to the 1999 Geneva Act to 73. With the ratifications of the 1999 Geneva Act by Greece and Italy, a major milestone has been reached as all members of the European Union that have previously acceded to the 1960 Hague Act have now acceded to the 1999 Geneva Act...
