#### 1. Extension of time limits - Ukraine

EXPIRING BETWEEN 02 JUNE 2022 TO 01 SEPTEMBER 2022

A new extension has been granted for all parties in proceedings before the Office having their residence or registered office in Ukraine. The three-month extension published on 1 June extends all time limits expiring between 2 June 2022 and 1 September 2022, inclusive, until 2 September 2022. This extension follows Decision EX-22-4 of the Executive director, which extended all time limits expiring between 1 April 2022 and 1 June 2002, inclusive, until 2 June 2022, and Decision EX-22-2 which extended all time limits expiring between 24 February 2022 and 31 March 2022, inclusive, until 1 April 2022. On March 9 the EUIPO, in collaboration with the EU institutions, announced a number of measures in response to the military aggression carri... Read more

# 4. EPO and IP Australia make their PPH fast-track programme permanent

The Patent Prosecution Highway (PPH) programme between the EPO and IP Australia (IPA) becomes permanent on 1 July 2022. The current conditions and requirements for participation will continue to apply.

The offices have agreed to permanently extend the agreement, following the successful completion of a pilot programme, which was initially launched in July 2016 and extended in July 2019.

The EPO's PPH portfolio - In addition to this PPH programme, the EPO has operational PPH pilot programmes with the IP5 offices (the grouping of the world's five largest IP offices, made up of the European Patent Office (EPO), the Japan Patent Office (JPO), the Korean Intellectual Property Office (KIPO).. Making the program ongoing means Australian applicants can continue to request fast-track examination of their corresponding patents filed with the EPO, the 2nd most popular destination for Australian patent filings overseas. The IP Australia-EPO PPH program covers both Patent Cooperation Treaty (PCT) and Paris Route applications.

Through this, IP Australia and the EPO are able to use the work previously done by the other office.

The Eurasian Patent Office (EAPO) informs all interested parties that from July 1, 2022, the EAPO will start operations as an International Searching Authority (ISA) and an International Preliminary Examining Authority (IPEA) under the Patent Cooperation Treaty (PCT). The decision to appoint the EAPO as an ISA and IPEA was made at the 53rd session of the Assembly of the PCT Union, which took place in October 2021.

The amounts of fees paid for international search and international preliminary examination and other actions performed by the EAPO in connection with the performance of the functions of ISA and IPEA are published on the EAPO... Read more

## 8. National Collection of Switzerland Now Available in PATENTSCOPE

The national patent collection of Switzerland is now available in WIPO's global <u>patent search system PATENTSCOPE</u>.

It includes over 722,150 patent documents. Among which over 474,400 titles are in German, 135,980 in French, 52, 890 in English and 10,910 in Italian.

The addition of the national collection of Switzerland brings to 75 the number of national/regional collections available in PATENTSCOPE and to 100 million the number of national/regional collection documents —

it is recalled that documents are aggregated in PATENTSCOPE: republications do not count as one document. <u>Read more</u>

# 10. China Joins WIPO's Hague System and the Marrakesh Treaty

During the opening ceremonies of the Beijing 2022 Olympic Winter Games in February 2022, China officially deposited its instruments of accession to World Intellectual Property Organization (WIPO) Director General Daren Tang. The accession documents were for China to join The Hague System and the Marrakesh Treaty. Both of these treaties took effect in China on May 5, 2022. China became the 68th contracting party to the 1999 Geneva Text and the 77th member state of the Hague Union. The Hague Agreement was first adopted in 1925, establishing an international system that allows industrial designs to be protected in multiple countries or regions with... Read more

## 12. Fast-track patent examination launched with Saudi Arabia

ENTERS INTO FORCE ON 1 JULY 2022 FOR AN INITIAL 3-YEAR-TERM

The EPO and the Saudi Authority for Intellectual Property (SAIP) are launching their joint Patent Prosecution Highway (PPH) pilot programme to enable accelerated treatment of patent applications in both regions. The agreement enters into force on 1 July 2022 for an initial 3-year-term. This follows the signing of a Reinforced Partnership agreement in November 2021 and the renewal of an overarching Memorandum of Understanding on bilateral co-operation between the EPO and SAIP in June 2022. Under the pilot programme, applicants whose claims have been examined by the EPO or SAIP may ask for accelerated processing of their corresponding application at the other office. The two offices will also share existing work results and data... Read more

Of the seventeen, the JPO has the highest volume of international applications (ranking #7 in 2021 among the top origin of international applications). The Madrid e-Filing service enables Japanese users to electronically file international applications, by-passing a cost-and time-consuming development of our Office's own IT system. The exchange of diplomatic instruments was subsequently completed on June 6, opening a new chapter of cooperation between Taiwan and India in the field of IPR.
