9. Vringo Loses Appeals Court Ruling in Google Patent Case.

Google Inc. (GOOG) won its bid to overturn a \$30.5 million patent-infringement verdict, a reversal that sent shares of Vringo Inc. (VRNG) down 72 percent. The U.S. Court of Appeals for the Federal Circuit in Washington determined that the Vringo patents in the case were invalid.

10. Dandi Salt v. Union of India: Copyright Board may consider Review Applications

Justice Vibhu Bakhru of the Delhi High Court recently passed an order stating that the Registrar of Copyrights does not have the power to adjudicate upon the merits of an application preferred by the Copyright Board, and that the Copyright Board may review its own decisions. The review application was initiated by the petitioners by after their delayed appeal was rejected by the Registrar.

12. New law to crack down on patent trolls.

Apple Inc. failed again to win a sales ban on Samsung Electronics Co. products found to infringe its smartphone patents, even after requesting what it described as a more limited prohibition.

14. Japan's attempt to get in stricter patent protection into free trade agreement raises concern.

Japan's attempt to get in stricter patent protection laws at the just-concluded round of negotiation of Regional Comprehensive Economic Partnership (RCEP) which includes India. At the third round of negotiation this year, Japan had tabled a proposal called the Elements paper which included stringent measures on intellectual property.

15. Domain Name News: Indian Government Launches 'Desi' Domain Names; Reliance Withdraws Bid for '.indians'.

The Internet Corporation for Assigned Names and Numbers (ICANN) had recognized the need to make the internet accessible in more languages and had made Internationalised Domain Names (that is, Domain Names in non-Latin scripts) available to governments back in 2011. Three years later, the National Internet Exchange of India (NIXI) has now decided to release Internationalised Domain Names in seven Indian Languages.
