IPONZ has recently updated a number of guidelines relating to trade mark and patent proceedings. Following recent reviews and technical focus group discussions, our Hearings Office has updated a number of guidelines and practices.

Implementation of use of electronic bundles at hearings - We have begun to transition towards the use of electronic bundles in hearings. This will gradually replace the current practice of requiring all parties to file hard copies of the bundle in advance of their hearing.

The webinars, held August 4 to 5, were conducted by the Bureau of Patents (BOP), in coordination with Clarivate Analytics and CAS-American Chemical Society, which respectively maintain the Web of Science (WoS) and the Scientific and Technical information Network (STNext). As of 13 August 2021, the Namibian Business and Intellectual Property Authority (BIPA) will be included in TMclass. BIPA will join with the alphabetical list of the Nice classification. The inclusion of BIPA in TMclass brings the total number of participating national and regional IP offices, including ARIPO, OAPI, WIPO and the EUIPO, to 86. TMclass offers users the opportunity to search for and translate goods and services to and from any of the 44 languages available as well as verifying the terms' correct classification under the Nice classification. The incorporation of BIPA in TMclass is a concrete result of the EU funded project called Intellectual Property Rights (IPRs) Action for Africa (AfrIPI), which is directed by the European.. DABUS (which stands for "device for the autonomous bootstrapping of unified sentience") is an AI system created by Stephen Thaler, a pioneer in the field of AI and programming. The Intellectual Property Office of the Philippines' (IPOPHL) online trademark filing tool is now using the European Union's (EU) harmonized database of goods and services (HDB), currently the largest multilingual trademark classification database in the world. The HDB contains over 78,000 terms which users can choose from when indicating the nature of the goods and services for which the mark is sought. All terms in the HDB are automatically approved by all trademark offices in the EU. Describing the goods and services associated to a trademark is a critical step in application. This will set the limits of the trademark protection sought for and help IP offices determine whether a mark has confusingly similarity with another in the... Read more

DUBAI - The Government of the United Arab Emirates (UAE) has issued Federal Law No. (11) of 2021 replacing the previous Industrial Property Law No. (31) of 2006 on Regulation and Protection of Industrial Property of Patents, Industrial Drawings and Designs.

The new law applies to patents, utility models, industrial designs and trade secrets in the UAE, and aims to protect industrial property and regulate the procedures of registration, use, exploitation, and assignment, to ensure support for knowledge and innovation in the UAE. The new law was published in the official gazette number (703 - Annex) on May 31, 2021, and will enter into force six months after the date of publi... Read more

9. FDA Approves First Interchangeable Biological Product

Last week the U.S. Food and Drug Administration approved an interchangeable biosimilar to insulin glargine, an approval notable because it is the first approved interchangeable biosimilar product. The product is Semglee (insulin glargine-yfgn), produced by Mylan Pharmaceuticals, Inc., and under this approval, it is interchangeable with Lantus (insulin glargine) made by Sanofi. The approval was based on the provisions of the Biological Price Competition and Innovation Act of 2009 (BPCIA), enacted with the Affordable Care Act (commonly known as "Obamacare") codified at 42 U.S.C. § 262 et seq. Subsection (k) relates to the standards for biosimilarity; the FDA (and the statute itself) distinguish between biosimilarity and interchan... Read more

Effective today, 3 August 2021, the Banjul Protocol is now effective in The Gambia, making it the 12th contracting State of the Banjul Protocol. The Gambia can now be designated in any ARIPO mark application under the Protocol.

The Government of the Republic of The Gambia deposited its Instrument of Ratification to the Banjul Protocol on Marks with the Director General of ARIPO on 3 May 2021.

Furthermore, The Gambia nationals and residents are entitled, as of 3 August 2021, to file mark applications directly with the ARIPO Office if they so wish. <u>Read more</u>

The Intellectual Property Office of the Philippines (IPOPHL) is one of the top performing international patent authorities in terms of completion and transmittal of international search report (ISRs) to the World Intellectual Property Organization (WIPO), according to WIPO's Patent Cooperation Treaty (PCT) Yearly Review 2021. Based on WIPO's 2020 global data, the review said the Philippines, through IPOPHL, which operates as an international searching authority and international preliminary examining authority (ISA/IPEA) for the PCT, was able to complete and transmit 100% of ISRs requested at its Office (Fig.1), and achieve 100% compliance in the timeliness of transmittal within the prescribed deadline of nine months from priority...
