01. Service by Publication

LAWS & REGULATIONS ON INDUSTRIAL PROPERTY (JPO) For cases where documents have not been serviced by delivery (undeliverable to the recipient, etc.), the JPO eventually executes Service by Publication by means of publicizing such information in the Official Gazette and the Patent Gazette, posting in the area designated for posting at the JPO office, or displaying on PCs placed at the JPO office for public perusal. (Patent Act Article 191 (where applicable mutatis mutandis to Article 55-2 of the Utility Model Act, Article 68-5 of the Design Act, and Article 77-5 of the Trademark Act.) SHAPING EUROPE'S DIGITAL FUTURE THROUGH STANDARDS AND PATENTS Technology standards are the silent powerhouses behind today's digital economy. Today, the European Patent Office (EPO) published a study that reveals the clear link between technology standards and patents. The study leverages the EPO's vast prior art databases, which include over 5.5 million documents from standards development organisations (SDOs), a unique collection curated through close collaboration over the past two decades. The study also analyses recent European case law on Standard Essential Patents (SEPs). The EPO study, titled Standards and the European patent system, introduces a new dataset that reveals with greater clarity than ever before how standards documentation is used in the examination of European patent applications, and also how often... <u>Read more</u>

Overall Trends in Patent and Trademark Applications: In the first quarter of 2025, TIPO received a total of 17,063 patent applications, comprising 12,202 invention patents, 3,232 utility model patents, and 1,629 design patents. This represents a 1% increase compared to the same period in 2024, with invention patent filings rising by 2% (Figure 1). Patent applications filed by resident and non-resident applicants accounted for 47% and 53% of the total, respectively. Compared to the same period last year, applications by residents declined by 2%, whereas those by non-residents rose by 5%.

A total of 21,099 trademark applications were filed. Since a single trademark application may be designated across multiple classes, the total number of classes covered by trademark... <u>Read more</u>

08. USPTO announces new filing option available online for Trademark Trial and Appeal Board customers

USPTO LAUNCHES TTAB CENTER FOR ONLINE FILING OF TRADEMARK CANCELLATION PETITIONS The U.S. Patent and Trademark Office announces an added option for Trademark Trial and Appeal Board (TTAB) customers to file a petition for cancellation in our new system, TTAB Center. The new filing functionality will be available on May 12, 2025. Currently, petitioners can file using either TTAB Center or the existing filing platform, the Electronic System for Trademark Trials and Appeals (ESTTA). Starting on July 12, 2025, users will no longer be able to file petitions for cancellation through ESTTA. A cancellation proceeding is a TTAB proceeding in which a party may seek to cancel an active trademark registration.
